BOARD OF GEOLOGISTS – NOTICE OF REGISTRATION CERTIFICATE RENEWAL 2017

This letter is to notify that the registration certificate for registered Geologist / Practitioner shall expire on 31.12.2016 and has to be renewed. Consequently, you are required to submit the application for renewal together with the renewal fee according to registration category on or before **31.1.2017**.

2. The registration certificate renewal for Professional Geologist/ Graduate Geologist / Practitioner / Foreign Geologist for year 2017 can be made as explained below:

(i) Completed Form F.

(ii) Payment of Renewal Fee as indicated in the following table:

Category	Renewal Fee	Annual Renewal Registration Deadline
Registered Graduate Geologist	RM50.00	On 31 January of the following year after the registration year expires.
Registered Professional Geologist	RM200.00	On 31 January of the following year after the registration year expires.
Registered Practitioner	RM200.00	On 31 January of the following year after the registration year expires.
Registered Foreign Geologist	RM1000.00	On 31 January of the following year after the registration year expires.

3. Please note that if registration with BoG is not renewed, it is an offense for a person to practice geology or carry on business as a Registered Geologist as provided in Section

23 of the Geologist Act 2008. Also if a person failed to renew the registration with BoG, the registration will automatically be canceled with effect from **1.2.2017** and action will be taken to remove the person's name from the Registry Board of Geologists Malaysia.

4. The **2017 Registration Certificate** will only be issued after application **Form F** is received and the respective renewal fee is paid. Payment can be made to 'Lembaga Ahli Geologi' (Maybank Account No. 564052522670) in cash /online /money order /bank draft /cheque.

5. Every registered person shall notify the registrar of any change in their your business address as required under Section 32 of the Geologists Act 2008. Failure to notify without reasonable excuse is an offence, and if convicted, could be liable to a fine as described in the Subsection 32(2) .
